Homeowners

For homeowners who are having a difficult time making payments on their mortgage, there are a couple of options available.

- Homeowner Affordability and Stability Plan On March 4, 2009, President Obama released details for the Homeowner Affordability and Stability Plan. The plan is designed to further address the current housing crisis, allowing responsible homeowners with loans owned or guaranteed by Fannie Mae or Freddie Mac to refinance their mortgage and stay in their home. The new plan addresses not only those already in foreclosure, but those who are potentially facing foreclosure while still being current on their payments.
